RESOLUTION NO. 2022-263

A RESOLUTION FORMALLY ORGANIZING THE PEOPLE'S LAW ENFORCEMENT BOARD OF THE MUNICIPALITY OF MALILIPOT, ALBAY.

WHEREAS, under Section 43 (b) of RA 6975 (Department of Interior and Local Government Act of 1990) as amended by RA 8551 otherwise known as the Philippine National Police Reform and Reorganization Act of 1998, the composition of the PLEB shall be as follows:

1. Any member of the sangguniang panlungsod/bayan chosen by his respective sanggunian;
2. Any barangay captain of the city or municipality concerned chosen by the association of barangay captains; and
3. Three (3) other members who are removable only for cause to be chosen by the local peace and order council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another a member of the Bar, or, in the absence thereof, a college graduate, or the principal of the central elementary school in the locality."
